WEB NOTE

As per G.O.Ms.No.244 GENERAL ADMINISTRATION (SER.D) DEPARTMENT Dated:24/08/2021 at Para No 7(ii), it has been mentioned as follows,

“Persons who are not covered under the scheme of reservation for SCs, STs and BCs and whose family has gross annual income below Rs. 8.00 lakh (Rupees Eight Lakh only) are to be identified as EWS for benefit of reservation. Income shall also include income from all sources i.e., salary, agriculture, business profession etc. for the financial year prior to the year of application.”

TSPSC has called applicants who have applied for the post Assistant Executive Engineer for Certificate Verification in the ratio of 1:2 / 1:5 (PWD), and after completion of Certificate Verification it has been noticed that certain candidates who are in the pick-up list have not submitted correct EWS certificate.

The Notification for Assistant Executive Engineer has been issued during the financial year 2022-2023. Hence, candidates claiming EWS reservation have to submit EWS certificate for the financial year 2021-2022. Hence, the following candidates are informed to submit EWS certificate for the year 2021-2022 by 22/05/2024 in O/o TSPSC, Prathibha Bhavan, Nampally, Hyderabad.
