BASED ON THE ORDERS OF THE HON'BLE HIGH COURT IN W.A.No. 551/2019, DATED: 03/07/2019 ETC.,

In continuation to the selection Notification dated: 12/02/2019, 21/06/2021, 24/08/2021, 24/09/2021, 13/12/2022 and 19/05/2023 of provisionally selected candidates for the post of Forest Beat Officer in Forest Department, vide **Notification** No.48/2017, the revision of selection was taken up based on the Common Orders of the Hon'ble High Court In W.A.No. 1369/2018 (including 5 WPs. 21475/2018, 21514/2018, 22756/2018, 22275/2018 & 22165/2018) pertaining to the recruitment of Forest Beat Officer are included in the common order and in compliance with orders of Hon'ble High Court in W.P. No.4495 of 2019, dated:11/06/2019 and W.A No.551 of 2019 dated:03/07/2019 and others whereby selected candidates were first permitted to join and the remaining vacancies, were considered for further selection with next meritorious candidates. On the basis of the list received from the Forest department i.e., non-joining and not genuine report pertaining to agency area of Adilabad District the commission declared the revised result of provisionally selected candidates pertaining to agency area of Adilabad District.

The District / Division / Unit of already appointed of general and agency candidates vide selection notification dated: 24/09/2022 has changed to their more preferred posts / places according to the web options given. The selection of these new candidates are published here with subject to the following conditions.

- 1) The following Hall ticket numbers have been provisionally selected for appointment to the post of FOREST BEAT OFFICER IN FOREST DEPARTMENT vide Commission's Notification No.48/2017, Dated: 15/08/2017. That success in the examination confers no right to appointment unless the appointing authority is satisfied after such enquiry as the case may be considered necessary, that the candidate having regard to her/his character and antecedents is suitable in all respects for appointment to the service.
- 2) That the candidate is found physically fit for the post.
- 3) That the candidate should produce such original certificates as required in accordance with the rules/notification.
- 4) The selection of ST Candidates those who claimed as local to Agency Area Certificate, is subject to receipt of final report of the appointing authority in terms of G.O.Ms.No.24, TW(LTR), Dated:12-6-2018.
- 5) The selections are subject to the final outcome of W.P.s and other cases pending, if any, before the Hon'ble High Court of law.
