ORDER:

Government have issued orders organizing posts in the civil services and civil posts under the State into various local cadres for different parts of the State as per the provisions of paragraph 3 of Presidential Order-2018, vide G.O.Ms.Nos.141 to 221 GA (SPF-I) Department dated: 04.08.2021. Consequent on the implementation of the provisions of Presidential Order-2018, there are now 33 district cadres, 7 zonal cadres and 2 multi-zonal cadres in respect of posts to which the provisions of Presidential Order-2018 apply. It, therefore, necessarily follows that unit of appointment in respect of these posts has to be a district, zone or multi-zone, as the case may be, in respect of posts organized into district cadre, zonal cadre and multi-zonal cadre, respectively.

2. The Special rules in respect of State and subordinate services under various departments, in general, have a provision prescribing the unit of appointment for each category of posts. The units of appointments in the existing rules are in conformity with the cadres organized under Presidential Order-1975. Hence, it is imperative that the special rules are amended so that the units of appointment synchronize with the local cadre into which the post is organized as per Presidential Order-2018.

3. Rule-7 of the Telangana State and Subordinate Service Rules, 1996, stipulates the appointing authorities in respect of State service posts. The special rules for various services in all departments also have a provision specifying the appointing authorities for each class and category of posts. These provisions may also require amendment in view of formation of new districts, organization of new local cadres under Presidential Order-2018 and also doing away with the regional offices in certain districts. Pending suitable amendments to the special rules, a special provision shall be made in the State and Subordinate Service Rules, 1996.

4. Government after careful examination of the matter hereby issue the following amendment to the Rule 7 of the Telangana State and Subordinate Service Rules, 1996 issued vide G.O.Ms.No.436, General Administration (Services-D) Department, dated: 15.10.1996 read with G.O.Ms.No.196, General Administration (Services-D) Department, dated: 28.05.2016.

5. Accordingly, the following notification shall be published in the Telangana Gazette dated: 19.03.2022.

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of Constitution of India and all other powers hereunto enabling, the Governor of Telangana, hereby makes the following amendments to the Telangana State and Subordinate Service Rules, 1996 issued in G.O.Ms.No.436, General Administration (Services-D) Department, dated the 15th October, 1996 read with G.O.Ms.No.196, General Administration (Services-D) Department, dated the 28th May, 2016 and published in Part-I Extraordinary Issue of the Telangana Gazette No.97, dated: the 28th May, 2016 as subsequently amended from time to time.

AMENDMENT

In the Telangana State and Subordinate Service Rules, 1996, the Rule-7 shall be substituted with the following, namely:-

"7. Unit of Appointment and Appointing Authority:

(1). Notwithstanding anything contained in the special rules or any other law, rules or orders, the unit of appointment for the posts organized as district, zonal and multi-zonal cadres under the provisions of the Presidential Order, 2018, shall be the district, zone and multi-zone, respectively.

(2). Notwithstanding anything contained in the Special Rules, the State Government or such other officer as may be notified by the State Government, the Head of the Department or such other officer as may be notified by the State Government and the District Head of the Department or such other officer as may be notified by the Head of the Department shall be the appointing authority in respect of posts organized as multi-zonal, zonal and district cadres under the provisions of the Presidential Order, 2018, respectively.

(3). Subject to any provision made in this regard in the Special Rules, Government shall be Appointing Authority for the third level and above gazetted posts in the State Service, other than those mentioned in sub rule (2) above".


