- In the said G.O., in para 5, Scheme of Examination and Pattern for various categories of posts to be filled by TSPSC, under (B) Group-II Services, the following posts shall be added:
 - Assistant Section Officer (Telangana State Election Commission Service)
 - 18. Assistant Section Officer (in any other department)
 - 19. District Probation Officer (Juvenile Correctional Service)
 - 20. Assistant B.C. Welfare Officer (B.C. Welfare Sub Service)
 - 21. Assistant Tribal Welfare Officer (Tribal Welfare Sub Service)
 - 22. Assistant Social Welfare Officer (S.C.D.D. Sub Service)
- In the said G.O., in para 5, Scheme of Examination and Pattern for various categories of posts to be filled by TSPSC, under (C) Group-III Services, the following posts shall be added:
 - Accountant (Tribal Welfare State Service)
 - 10. Senior Assistant/Accountant or Junior Assistant/Accountant or any other similar categories in HODs.
- 3. In the said G.O., in para 5, Scheme of Examination and Pattern for various categories of posts to be filled by TSPSC, under (D) Group-IV Services, the existing entries shall be substituted with the following:
 - 1. Junior Assistant, Junior Accountant, any other equivalent/similar categories in District offices of various departments.
