**ORDER:**

Government have issued orders, regarding classification of posts, Scheme and Pattern of Examination for various categories of posts under various Groups and other services to be filled-up by direct recruitment through Telangana State Public Service Commission, in the G.O. first read above.

2. The Secretary, Telangana State Public Service Commission, Hyderabad, vide letters third and fourth read above, has proposed certain amendments to Para-B of Pattern of Examination under the Scheme of Examination for Group-I services prescribed in the Government Order first read above, in the light of certain court cases filed in this regard and the observations of the Supreme Court of India in the case of A.P. Public Service Commission Vs. Baloji Badhavath & others (Civil Appeal No.2244 of 2009, dated: 08.04.2009).

3. Government, after careful examination of the proposal of the Telangana State Public Service Commission, Hyderabad, hereby make the following amendment to the Scheme of Examination and Pattern for various categories of posts to be filled by the Telangana State Public Service Commission issued in G.O.Ms.No.55, GA (Ser.A) Department, Dated 25.04.2022:-

**AMENDMENT**

In the said G.O.

in para 5, under Pattern of Examination, for Para-B, the following shall be substituted, namely,-

“B. The number of candidates to be admitted to the written (Main) examination (Conventional Type) would be fifty (50) times to the total number of vacancies available in each Multi-Zone:

Provided that, in case of any shortfall in respect of candidates in reserved categories as laid down in rules 22 & 22 A of the Telangana State and Subordinate Service Rules, 1996, action shall be taken to include such number of candidates from the merit list beyond 1:50 ratio, as required to meet the shortfall in the respective categories.”.

4. The Secretary, Telangana State Public Service Commission, Hyderabad shall take necessary further action in the matter accordingly.
