Police – Rules – Reduction in minimum height requirement in respect of Men and Women candidates for Direct Recruitment to the category of Deputy Superintendents of Police (Civil) – Adhoc Rule – Notification - Orders - Issued

ORDER:

The Director General of Police, TS, Hyderabad vide reference 2nd read above, has informed that there is a request to lower the minimum height criteria for the post of Deputy Superintendents of Police (Civil) from 167.6 cms to 165 cms for Men and from 152.5 cms to 150 cms for Women, duly amending the Telangana State Police Service (Civil) Rules, 1998, issued in the G.O. 1st read above, to enable more number of candidates to participate and compete for direct recruitment to the post of Deputy Superintendent of Police (Civil). The Director General of Police, TS, Hyderabad has further informed that in respect of IPS Officers, the minimum height specified for Men is 165 cms and for Women is 150 cms.

2. The Director General of Police, TS, Hyderabad accordingly, recommended amendments to the rules keeping in view the height standards laid down for the IPS.

3. Government, after careful consideration of the proposal of the Director General of Police, TS, Hyderabad, have decided to issue Adhoc Rule, reducing the minimum height in respect of Men and Women candidates for direct recruitment to the category of Deputy Superintendent of Police (Civil).

4. Accordingly, the following notification shall be published in the Extra- Ordinary issue of the Telangana Gazette:

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of Constitution of India, the Governor of Telangana, hereby makes the following Adhoc Rule for the Direct Recruitment of Deputy Superintendent of Police (Civil) namely:-

ADHOC RULE

Notwithstanding anything contained in the Telangana State Police (Civil) Services Rules, 1998, issued vide G.O.Ms.No.137, Home (Police.E) Department, dated 01.06.1998 or in any other Special or Adhoc Rules, the minimum height in respect of Men, Women and STs for direct recruitment to the category of Deputy Superintendents of Police (Civil), shall be as follows:

Men - He shall not be less than 165 cms in height.
In respect of ST candidates, he shall not be less than 164 cms in height.

Women - She shall not be less than 150 cms in height.

This Adhoc Rule, shall be deemed to have come into force on 1st April, 2022.
