**DISPLAY OF TOTAL MARKS, GENERAL RANKING LIST AND MEMORANDUM OF MARKS**

**WEB NOTE**

The Commission has conducted Group-I Services Mains examinations from 21/10/2024 to 27/10/2024 in HMDA Jurisdiction. The valuation process of all the 7 papers is completed. The provisional marks secured by the candidates who have attended (7) papers of Mains examinations were placed in the respective candidate's login from 10/03/2025 to 16/03/2025 up to 5.00 PM for a period of one week.

As per Para 15 of Notification No. 02/2024 candidates were given provision to apply through online for recounting of Marks from 10/03/2025 to 24/03/2025 up to 5.00 PM for 15 days and the process of recounting of marks is completed.

In this connection, the Commission has decided to publish the total marks of the candidates who have attended all the seven papers on Commission website, Memorandum of Marks in candidate's login and General Ranking List (GRL) on the Commission's Website. General Ranking list is generated for the candidates who have qualified in General English Paper and secured minimum qualifying aggregate marks as prescribed for respective categories in Paras 12.1(D) and 12.8 of Notification No.02/2024. The Total Marks (Annexure-I) on Commission Website and Memorandum of Marks in Candidate's Login will be available from **30/03/2025 to 05/04/2025** up to 5.00 PM for 1 week. Candidates can download/view their Memorandum of Marks from individual logins by entering their TGPSC ID, Hall Ticket Number, Date of Birth and OTP received on their registered Mobile Number on the Commission's website. The General Ranking List (GRL) (Annexure-II) would be made available on the Commission's website **from 30/03/2025 to 28/04/2025** up to 5.00 PM for 30 days. Based on the General Ranking List (GRL), the required number of candidates would be picked up for certificate verification. Such candidates would be informed individually and also through TGPSC website.

The candidates are advised to keep all the required original Certificates and documents ready as mentioned at **Annexure-VI (at 1.9)** in the Group-I Services Notification No. 02/2024, Dt. 19/02/2024.

The marks of the candidates who were admitted for Mains Examination on the direction of Hon'ble High Court, are not displayed as per the orders of the Hon'ble High Court.
