**PROVISIONAL SELECTION NOTIFICATION**

It is hereby informed that the Provisional Selection Result Notification after Relinquishments for the posts of Physical Education Teachers in various Residential Educational Institutions Societies vide Notification No.16/2017, dated:14/04/2017 has been published on 17/09/2024 in which result of 14 candidates was kept withheld due to pending W.P. Nos. 1367/2018, 17938/2018, 18273/2018, 18877/2018 & 22909/2019 in the Hon'ble High Court of Telangana.

In continuation of the above Provisional Selection result notification dtd: 17/09/2024 after Relinquishments for the posts of Physical Education Teachers in various Residential Educational Institutions Societies vide Notification No.16/2017, dated:14/04/2017, it is hereby informed that, since the W.P.Nos.1367/2018, 18877/2018 & 22090/2018 have been dismissed and W.P.Nos.17938/218 & 18273/2018 were disposed by the Hon'ble High Court of Telangana, the provisional selection result of the following 14 candidates is herewith released with the following conditions.

1. That success in the examination confers no right to appointment unless the appointing authority is satisfied after such enquiry as the case may be as considered necessary, that the candidate having regard to his/ her character and antecedents is suitable in all respects for appointment to the service.
2. That the candidate is found physically fit for the post.
3. That the candidate should produce such original certificates as required in accordance with the rules/notification.
