DECLARATION OF RESULT OF THE WITHHELD VACANCIES SINCE 19 WRIT PETITIONS
ARE DISMISSED IN THE HON'BLE HIGH COURT: PRINCIPAL SCHOOLS

In continuation to the selection Notification Dt:08/03/2021 of provisionally selected 186 candidates for the post of **Principal (Schools)** vide Notification No.29/2017 against a total number of 303 vacancies in various Residential Educational Institutions Societies, the following 9 (nine) candidates are newly selected provisionally, for appointment to the post of Principal (Schools) due to dismissal of the 19 pending Writ Petitions in the Hon'ble High Court. The selection has been verified and published here with subject to the following conditions.

- 1) That success in the Examination confers no right to appointment unless the appointing authority is satisfied after such enquiry as the case may be considered necessary that the candidate having regard to his/her character and antecedents is suitable in all respects for appointment to the service.
- 2) That the candidate is found physically fit for the post.
- 3) That the candidate should produce such original certificates as required in accordance with the Rules / Notification.
