**Incompliance with the Hon'ble High Court orders in W.P No.20340 of 2018 & 20176 of 2018 in the common order in WA No.1369/2019, Dt:19/07/2021 & Withdrawal by petitioner in WP No.30926/2018 before the Hon'ble High Court**

In continuation to the provisional list of selected candidates published vide selection Notification Dt:12.02.2019 to the Post of School Assistant – Social Studies – Telugu Medium, notified vide notification no.52/2017 for a total no. of 699 vacancies in School Education Department. The following result is being released in compliance with the Hon'ble High Court orders in W.P No. 20340 of 2018 & 20176 of 2018 in the common order in WA No.1369/2019, Dt:19/07/2021 and in WP No.30926/2018. The selection is published here with subject to the following conditions:

- 1) That success in the Examination confers no right to appointment unless the appointing authority is satisfied after such enquiry as the case may be considered necessary that the candidate having regard to his/her character and antecedents is suitable in all respects for appointment to the service.
- 2) That the candidate is found physically fit for the post.
- 3) That the candidate should produce such original certificates as required in accordance with the Rules / Notification.
- 4) The allotment of candidate to a local cadre is subject to further procedure according to provisions G.O Ms. No.124, GA (SPF -MC) Department dated: 30.08.2018.
- 5) If it comes to the notice of the Commission later that any candidate furnished false information or the selection is not in order due to any act of omission or commission of any candidate then his/her provisional selection is liable to be cancelled at any stage and they will forfeit all consequential benefits including that of selection. Besides that, the Commission reserves the right to take any action as it deems fit in the circumstances of the case, in terms of the provisions as notified in TGPSC Rules of Procedure published in Telangana State Gazette No.60., Dt: 28/12/2015.
